Sabbath and Holiday Meals and Celebrations - Hillel provides Sabbath and Holiday meals to Jewish students at Queens College. The weekly Sabbath is a centerpiece of Jewish communal life, which is marked with festive meals, community gatherings, and opportunities to study Jewish texts, thought, and customs. We offered catered meals on 10 weekends serving more than 1,000 students. We also celebrated the various Jewish holidays that occurred during the academic year, providing meals, services, and cultural celebrations. These events created opportunities for students to gather in prayer, study, and camaraderie. The feeling of community took our efforts to create meaningful Jewish experiences to a whole new level.

Jewish Journeys and Israel Engagement: Hillel encourages students to make an enduring commitment to Jewish life, learning, and Israel. Our approach is to present students with an opportunity to build relationships with Jewish text and tradition and with Israel that is both personal and deep. We offer many Jewish learning programs to serve students across the Jewish community, including opportunities to engage in complex issues, and disagreements over how these values fit together. Whether a student is focusing on what it means to be a Jewish adult, what it means to feel connected to and show love for Israel, or are interested in studying our rich textual and scholarly tradition, we have resources to offer. Our approach to Israel engagement includes opportunities for students to learn, travel to Israel (Birthright) and engage in meaningful and constructive conversations with their peers about how they can connect Israel to their own lives.

Student Leadership Development- Hillel prides itself on producing highly skilled student leaders that take on leadership responsibilities in the Jewish community and beyond after they graduate. This includes mentorship of student leaders, travel and registration costs for leadership conferences, multiple student internships, stipends to make it possible for students to participate in broader community experiences, and the Council of Jewish Leaders- a roundtable gathering of the Presidents of all the Jewish student groups on campus to coordinate efforts, increase collaborations, and crowdsource solutions to leadership challenges.
