Sabbath Meals and Programs- Hillel provides Sabbath meals to Jewish students at Queens College. The weekly Sabbath is a centerpiece of Jewish communal life, which is marked with festive meals, community gatherings, and opportunities to study Jewish texts, thought, and customs. We offered catered meals on 10 weekends serving more than 1,000 students. These meals also created opportunities for students to gather in prayer, study, and camaraderie. The feeling of community took our efforts to create meaningful Jewish experiences to a whole new level.

Israel Education and Engagement Initiatives- Hillel's mission includes encouraging students to make an enduring commitment to Israel. Our approach is to present Israel as a deeply Jewish entity with strong Jewish values attached disagreements about which cause many of the problems Israel faces today both within and outside the Jewish community. Our approach includes opportunities for students to learn more about Israel, travel to Israel (Birthright), and to engage in meaningful and constructive conversations with their peers about how they can connect Israel to their own lives

Jewish learning initiatives- Hillel continued its Jewish learning offerings this year, including the JLIC (Jewish Learning Initiative) program to campus in partnership with the Orthodox Union, expansion of the Peer Network Engagement Initiative, and "Evolving Judaism" - a series on progressive Jewish ideas in collaboration with Mechon Hadar. These initiatives provide high-level Jewish content as lenses through which to view all Hillel's activities, and also as a standalone module for students for whom meaningful Jewish experiences will mostly come through study.
